Waiver and Release of Liability

In consideration of the risk of injury while participating in the Central Regional Trials Championship series ("the Activity"), and as consideration for the right to participate in the Activity, I hereby for myself my heirs executors, administrators, assigns, or personal representatives, knowingly and voluntarily enter into this waiver and release of liability and hereby waive any and all rights, claims, or causes of action of any kind whatsoever arising out of my participation in the Activity, and do hereby release and forever discharge Rick Rexroat and/or Central Regional Trials Championship located at 2005 W 55th Street South, Wichita Kansas 67217, their affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors, assigns and sponsors for any physical or psychological injury including but not limited to illness, paralysis, death, damages, economical or emotional loss, that I may have suffer as a direct result of my participation in the aforementioned Activity, including traveling to and from as event related to this Activity.

I AM VOLUNTARILY PARTICIPATING IN THE AFOREMENTIONED ACTIVITY AND I AM PARTICIPATING IN THE ACTIVITY ENTIRELY AT MY OWN RISK, I AM AWARE OF THE RISKS ASSOCIATED WITH TRAVELING TO AND FROM AS WELL AS PARTICIPATING IN THIS ACTIVITY, WHICH MAY INCLUDE, BUT ARE NOT LIMITED TO PHYSICAL OR PSYCHOLOGICAL INJURY, PAIN, SUFFERING, ILLNESS, DISFIGUREMENT, TEMPORARY OR PERMANENT DISABILITY (INCLUDING PARALYSIS) ECONOMIC OR EMOTIONAL LOSS, AND DEATH. If Rick Rexroat and/or Central Regional Trials Championship incurs any of these types of expenses, I agree to reimburse Rick Rexroat and/or Central Regional Trials Championship.

I acknowledge that Rick Rexroat and/or Central Regional Trials Championship and its directors, officers, volunteers, representatives, agents and sponsors are not responsible for errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity of behalf of the Central Regional Trials Championship.

I ACKNOWLEDGE THAT THIS ACTIVITY MAY INVOLVE A TEST OF A PERSON'S PHYSICAL AND MENTAL LIMITS AND MAY CARRY WITH IT THE POTENTIAL FOR DEATH, SERIOUS INJURY, AND PROPERTY LOSS. The risks may include but are not limited to, those caused by terrain, facilities, temperature, weather, lack of hydration, condition of participants equipment, vehicular traffic and actions of others, including but not limited to participants, volunteers, spectators, coaches, event officials and event monitors, and or producers or sponsors of the event.

I ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS "WAIVER AND RELEASE" AND FULLY UNDERSTAND THAT IT IS A RELEASE OF LIABILITY. I EXPRESSLY AGREE TO RELEASE AND DISCHARGE CENTRAL REGIONAL TRIALS CHAMPIONSHIP AND ALL OF ITS AFFILIATES, MANAGERS, MEMBERS, AGENTS, ATTORNEYS, STAFF, VOLUNTEERS, HEIRS, REPRESENTATIVES, PREDECESSORS, SUCCESSORS, ASSIGNS AND SPONSORS, FROM ANY AND ALL CLAIMS OR CAUSES OF ACTION AND I AGREE TO VOLUNTARILY

GIVE UP OR WAIVE ANY RIGHT THAT I OTHERWISE HAVE TO BRING A LEGAL ACTION AGAINST RICK REXROAT OR CENTRAL REGIONAL TRIALS CHAMPIOSHIP FOR PERSONAL INJURY OR PROPERTY DAMAGE.

To the extent that statute of case law does not prohibit releases for negligence, this release is also for negligence on the part of Rick Rexroat and/or Central Regional Trials Championship, its agents and employees.

In the event that I should require medical care or treatment. I agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.

In the event that any damage to equipment of facilities occurs as a result of my or my family's willful actions, neglect or, recklessness. I acknowledge and agree to be held liable for any and all costs associated with any action of neglect or recklessness.

This agreement was entered into at arm's-length. without duress or coercion. and is to be interpreted as an agreement between two parties of equal bargaining strength. Both the Participant, Rick Rexroat and Central Regional Trials Championship agree that this agreement is clear and unambiguous as to its terms, and that no other evidence will be used or admitted to alter or explain the terms of this agreement. but that it will be interpreted based on the language in accordance with the purpose for which it is entered.

In the event that any provisions contained within this release of liability shall be deemed to be severable or invalid or if any term, condition, phrase, or portion of this agreement shall be determined to be unlawful or otherwise unenforceable, the remainder of this agreement shall remain in full force and effect, so long as the clause severed does not affect the intent of the parties. If a court should find that any provision of this agreement to be invalid or unenforceable but that by limiting said provision it would become valid and enforceable the said provision shall be deemed to be written, construed and enforced as so limited.
